1. OVERVIEW

These Master Terms of Service (“**Terms**”) govern your access to and use of any websites, software, applications, digital platforms, or services operated by **Amazing Life Foundation** (“**Amazing Life**,” “**we**,” “**us**,” or “**our**”), including without limitation:

APlay, APlay Pro, Service Builder, APlay View, Parent+, and Amazing Music, together referred to as the “**Services**.”

By accessing or using any Service, you agree to be bound by these Terms, along with all policies incorporated by reference, including our **Privacy Policy, Subscription Auto-Renewal Terms**, and any product-specific Usage Guidelines or End User License Agreements (“**Supplemental Agreements**”).

If you do not agree, you may not access or use the Services.

2. DEFINITIONS

- “**Amazing Life**” means Amazing Life Foundation, a nonprofit corporation organized under the laws of the State of Texas, with principal offices in **Collin County, Texas**.
 - “**Services**” means all websites, platforms, applications, products, and materials operated or provided by Amazing Life.
 - “**User**,” “**you**,” or “**your**” refers to any person or entity accessing or using the Services.
 - “**Content**” means all text, graphics, images, videos, audio, software, data, or other materials provided through the Services.

Amazing Life grants you a limited, non-exclusive, non-transferable, revocable license to access and use the Services for their intended ministry, educational, or personal purposes.

You may not:

- Copy, reproduce, or redistribute any Content except as expressly permitted;
- Record, capture, or rebroadcast any streamed media;
- Circumvent or disable any digital rights management or security feature;
- Use the Services for commercial resale, software scraping, or model training;
- Violate copyright, trademark, or other intellectual property rights;
- Interfere with or disrupt the Services or servers.

All rights not expressly granted are reserved by Amazing Life.
