

AMAZING LIFE FOUNDATION — PARENT+ APP TERMS OF USE

1. OVERVIEW

These Parent+ App Terms of Use (“**Terms**”) govern your use of the **Parent+** mobile, web, and Apple TV applications (collectively, the “**App**”), owned and operated by **Amazing Life Foundation**, a nonprofit organization based in Plano, Texas (“**Amazing Life**,” “**we**,” “**us**,” or “**our**”).

By installing, accessing, or using the App, you agree to these Terms as well as the **Master Terms of Service**, **Privacy Policy**, and **Subscription Auto-Renewal Terms**, all of which are incorporated by reference.

If you do not agree, do not use the App.

2. LICENSE TO USE THE APP

Amazing Life grants you a **limited, non-exclusive, non-transferable, revocable license** to access and use the Parent+ App for personal, non-commercial, household, and family purposes only.

You may:

- Stream or view videos, devotionals, and interactive content made available through Parent+;
- Create and manage family profiles for children or teens under your care;
- Access bonus materials associated with your Amazing Life curriculum subscription or Family Plan.

You may not:

- Record, download, copy, rebroadcast, or publicly perform App content;
- Display App media in church, school, or group settings without proper licensing (e.g., CCLI/CVLI);

- Share account credentials or permit access outside your household;
- Modify, reverse engineer, or redistribute any portion of the App;
- Use the App in violation of copyright, privacy, or other applicable laws.

All rights not expressly granted are reserved by Amazing Life.

3. ACCOUNT REGISTRATION AND ELIGIBILITY

To use Parent+, you must create an account or sign in through an approved platform (such as Apple ID or Google).

By registering, you confirm that:

- You are 18 or older (or have parental/guardian consent);
- The information you provide is accurate and current;
- You are the legal parent or guardian for any child profiles you create.

You are responsible for maintaining account security and for all activity under your login.

4. SUBSCRIPTIONS AND PAYMENTS

Certain Parent+ features require a paid subscription.

All billing, renewals, and cancellations are governed by our **Subscription Auto-Renewal Terms** and applicable App Store policies (Apple App Store or Google Play Store).

- Prices, tiers, and renewal periods will be disclosed at the time of purchase.
 - Subscriptions renew automatically unless cancelled at least 24 hours before renewal.
 - Refunds follow the **Return & Refund Policy** or the policies of your app store provider.

5. CHILDREN AND FAMILY USE

Amazing Life is committed to protecting family privacy.

- **Parents and Guardians** must create and supervise all child profiles.
- **Children Under 13** may use Parent+ only under a parent or guardian's account and supervision.
- You agree not to allow unsupervised use by minors or to provide inaccurate age information.

See our **Privacy Policy** (Section 9) for details on how we protect children's data in compliance with COPPA.

6. CONTENT AND INTELLECTUAL PROPERTY

All videos, devotionals, artwork, audio, and materials within Parent+ are the exclusive property of Amazing Life Foundation and its licensors.

You receive only a personal, limited streaming license.

You may not download, duplicate, or redistribute any content from the App.

All trademarks, logos, and names associated with Amazing Life, Parent+, and its curricula remain the property of Amazing Life Foundation.

7. USER CONDUCT

You agree not to:

- Post or transmit unlawful, offensive, or infringing material;
- Attempt to gain unauthorized access to the App or its systems;
- Interfere with App operation or security;
- Use automated systems to scrape or collect data.

Amazing Life reserves the right to suspend or terminate accounts violating these Terms.

8. PRIVACY AND DATA COLLECTION

Your use of Parent+ is subject to our **Privacy Policy**, which describes how we collect and use information about parents, guardians, and children.

We do not sell personal information and only share it as needed to operate the App (e.g., with payment processors or hosting providers).

9. UPDATES AND CHANGES

Amazing Life may update or improve Parent+ at any time.
You may be required to install the latest version to continue using the App.
We may also update these Terms periodically.
Material changes will be posted in-App or emailed to you.

10. TERMINATION

We may suspend or terminate your account if you breach these Terms or misuse the App.
Upon termination, you must stop using Parent+ and delete any cached copies.
Sections 6 (Intellectual Property), 10 (Termination), 11 (Disclaimers), and 12 (Limitation of Liability) survive termination.

11. DISCLAIMERS

Parent+ is provided “**as is**” and “**as available**.”
Amazing Life makes no warranties of any kind, express or implied, including merchantability, fitness for a particular purpose, or non-infringement.
We do not guarantee that the App will be uninterrupted or error-free.

12. LIMITATION OF LIABILITY

To the fullest extent allowed by law, Amazing Life Foundation and its officers, employees, and volunteers shall not be liable for any indirect, incidental, or consequential damages arising from your use of Parent+.

In no event shall Amazing Life’s total liability exceed the amount you paid for the subscription during the twelve (12) months preceding the claim.

13. INDEMNIFICATION

You agree to indemnify and hold harmless Amazing Life Foundation from any claims, damages, losses, or expenses arising from your use of Parent+, your violation of these Terms, or your infringement of third-party rights.

14. GOVERNING LAW AND JURISDICTION

These Terms are governed by the laws of the **State of Texas**.

All disputes shall be resolved exclusively in the state or federal courts located in **Collin County, Texas**, and you consent to their jurisdiction.
