

# TERMS AND CONDITIONS

## Automatic Renewal Subscription Agreement

Last Updated: April 28, 2026

Welcome to Think Orange, a subsidiary of Amazing Life Foundation! By subscribing to our Curriculum subscription, you agree to these Terms and Conditions. Please read them carefully.

---

## 1. Subscription and Automatic Renewal

### Subscription Term:

Your Curriculum subscription begins when you complete your purchase and continues for an initial term of one year ("Initial Term").

### Automatic Renewal:

UNLESS YOU CANCEL BEFORE RENEWAL, YOUR SUBSCRIPTION WILL AUTOMATICALLY RENEW FOR SUCCESSIVE ONE-YEAR TERMS ("RENEWAL TERMS") AT THE THEN-CURRENT RATE. YOUR PAYMENT METHOD WILL BE CHARGED AUTOMATICALLY ON OR AFTER THE APPLICABLE RENEWAL DATE UNLESS YOU CANCEL PRIOR TO RENEWAL.

### Early Renewal Option:

You may choose to renew your subscription early at any time before the automatic renewal date by contacting [customercare@amazinglife.com](mailto:customercare@amazinglife.com) or logging into your account and viewing your current subscriptions. Early renewal starts a new one-year Renewal Term from the date of your request, charged at the then-current rate.

### Billing:

You authorize Amazing Life Foundation ("Amazing Life") to charge your payment method (e.g., credit card, debit card, PayPal, ACH, or other approved payment method) the subscription fee for the Initial Term and each Renewal Term. Fees will be billed:

- At the time of initial purchase; and
- On or after the applicable renewal date for each Renewal Term unless canceled before renewal.

Taxes may apply.

### Price Changes:

We may adjust subscription fees for future Renewal Terms. We will notify you of any price increase at least 30 days before the renewal date using the email address associated with your account. Your renewal after the effective date of the updated pricing constitutes acceptance of the new fee.

### Content Access:

Your subscription provides access to curriculum for the duration of the active, paid subscription term. Access continues through the end of the current paid term and does not extend beyond expiration unless renewed. Downloaded content remains subject to the applicable license agreement and expires upon cancellation or non-renewal.

## 2. Cancellation and Refund Policy

### How to Cancel:

You may cancel your subscription by:

- Providing written notice with your Order ID number to [customercare@amazinglife.com](mailto:customercare@amazinglife.com); or
- Calling (866) 343-4874.

Cancellation timing affects future charges and access as outlined below.

### Cancellation Deadline:

To avoid being charged for the next Renewal Term, you must cancel before the applicable renewal date (i.e., before the end of the current term). Cancellation takes effect at the end of the current paid term, and no further renewal charges will occur.

### Initial Term Refunds:

The Initial Term is non-refundable. If you cancel during the Initial Term, you will not receive a prorated refund for unused months. Access will continue through the end of the paid Initial Term.

### Renewal Term Refunds:

If you cancel after a Renewal Term charge has been processed, cancellation will take effect at the end of the then-current Renewal Term. Renewal Term fees are non-refundable except where required by applicable law.

### No Other Refunds:

Except as expressly outlined above or required by applicable law, payments are non-refundable.

## 3. Consent to Auto-Renewal and Recurring Billing

### Explicit Consent:

By subscribing, you acknowledge and agree that:

- Your subscription will automatically renew unless canceled before the applicable renewal date;
- Your payment method will be charged automatically for each Renewal Term at the then-current rate;
- Charges will occur on or after the applicable renewal date unless canceled beforehand; and
- These automatic renewal and recurring payment terms will remain in effect until you cancel your subscription.

At checkout, you will confirm your agreement to these terms by checking a box or taking another affirmative action indicating:

"I agree to the Terms and Conditions, including automatic renewal and recurring billing terms."

### Authorization to Store Payment Information:

You authorize Amazing Life and its payment processors to store and maintain your payment information for recurring billing purposes consistent with applicable law and the Privacy Policy.

### Electronic Communications Consent:

You consent to receive electronic communications related to your subscription, including renewal reminders, billing notices, confirmations, pricing updates, and cancellation information, at the email address associated with your account.

## 4. Renewal Reminders

### Pre-Renewal Notice:

Where required by applicable law, or as otherwise determined by Amazing Life, we will send a renewal reminder to the email address associated with your account at least 30 days before the applicable renewal date. The reminder may include:

- The amount to be charged;
- The upcoming renewal date;
- Instructions for cancellation; and
- Information regarding any material changes to the subscription.

Please keep your contact information current.

## 5. Post-Purchase Confirmation

After your initial purchase, we will send a confirmation email summarizing your subscription details, including:

- Automatic renewal terms;
- Billing schedule;
- Pricing information;
- Cancellation instructions; and
- Refund policy information.

Retain this email for your records.

## 6. Your Responsibilities

### Payment Method:

You must provide and maintain a current, valid payment method. If a payment attempt fails, we may retry the charge, suspend access, or terminate the subscription until payment is received.

### Contact Information:

You are responsible for maintaining accurate and current email and billing information through your account settings or by contacting [customer@amazinglife.com](mailto:customer@amazinglife.com).

### Account Security:

You are responsible for maintaining the confidentiality of your account credentials and for all activity occurring under your account.

Nothing in these Terms limits any rights or remedies that may not be waived under applicable law.
